1. In this policy

- a. Act" means the College of Patent Agents and Trademark Agents, S.C. 2018, c. 27, s. 247.
- b. "licensee" has the same meaning as in the Act.
- c. "authenticity" includes: (i.) the fact that a document that is said to be an original was printed, written or otherwise produced and signed or executed as it purports to have been; (ii.) a document that is said to be a copy is a true copy of the original; and (iii.) where the document is a copy of a letter or electronic communication, the original was sent as it purports to have been sent and received by the person to whom it is addressed.

2. Policy

Section 63 of the Act provides that the Discipline Committee may make rules respecting the practice and procedure before them.

The purpose of the request to admit process is to create efficiencies in the disciplinary process, for the benefit of both parties to the proceeding, by narrowing the issues in dispute.

3. Procedure

1. At any time, but not less than 60 days before the date of the review or hearing by the Discipline Committee, a party may serve on the other party a request to admit the truth of a fact or the authenticity of a document for the purposes of the proceeding.



- 2. The request to admit must be in Form X, and must contain:
 - a. a complete description of the fact, the truth of which is to be admitted, or attach a copy of the document, the authenticity of which is to be admitted.
 - b. no more than 100 statements of fact and 100 documents, unless the other party consents or the Discipline Committee directs otherwise.
- 3. A party may only serve one request to admit on the other party in a proceeding, unless the other party consents or the Discipline Committee directs otherwise.
- 4. The party on whom the request to admit is served must serve a response no later than 30 days after the date of service, unless the other party consents or the Discipline Committee directs otherwise.
- 5. The response must be in Form Y, and, in relation to each fact described and each document attached to the request to admit, must:
 - a. admit the truth of the fact or the authenticity of the document.
 - b. specifically deny the truth of the fact or the authenticity of the document and set out the reason for the denial, or
 - c. refuse to admit the truth of the fact or the authenticity of the document and set out the reason for the refusal.
- 6. If the party on whom the request to admit was served fails to respond to the request, that party will be deemed to admit, for the purposes of the proceeding, the truth of the facts or the authenticity of the documents included in the request.
- 7. A party who is not satisfied with the response to a request to admit may file a motion to compel a proper response, failing which the facts included in the request are deemed to be admitted and the documents are deemed to be authentic. The motion must be filed at least 30 days prior to the date of the review or hearing by the Discipline Committee, unless the other party consents or the Discipline Committee directs otherwise.
- 8. If the party on whom the request to admit was served does not attend or does not participate in the Discipline Committee's review or hearing on the merits of the proceeding, the party is deemed to admit the truth of the facts or the authenticity of the documents mentioned in the request for the purposes of the proceeding, whether or not the party served a response.

- 9. If a party denies or refuses to admit the truth of a fact or the authenticity of a document after receiving a request, and the fact or the authenticity of the document is subsequently proved, the Discipline Committee shall take the denial or refusal into account in exercising its discretion respecting costs.
- 10. A party who has admitted or is deemed to have admitted the truth of a fact or the authenticity of a document under this policy may only withdraw the admission with the consent of the other party or with leave of the Discipline Committee.
- 11. Any request to admit served by the Investigations Committee on a licensee must attach a copy of this Policy.
